CALL TO ORDER

President George Williams called the six hundredth and fifty third meeting of the Carbon Lehigh Intermediate Unit Board of Directors to order at 6:30 p.m.

There was no audience input on the agenda.

The Board takes great pride in the CLIU and said the Leadership Team is phenomenal. He noted that the leadership and second-to-none services that are provided by the CLIU are in part what attracted him to this position. Dr. Koons said he and his family are thrilled and thanked the Board for this opportunity.

BOARD PRESIDENT'S REPORT

President Williams noted he will have to depart at 6:45 p.m. due to a Board meeting at the Whitehall-Coplay School District and Vice President Haas will take over for him after his departure.

He then reminded the CLSNCF Golf Tournament is coming up on Tuesday, June 17, 2025 at Olde Homestead Golf Course and noted that through the support of the foundation, Gemma, a service dog in training, was recently placed with the Titmus family in Whitehall. The welcome event was heartwarming and well-attended, with Gemma, fellow dogs, and even a chihuahua peacefully interacting. Gretchen and her family—who have been incredible caretakers—were recognized for their dedication, including a touching moment where they gifted Braille name necklaces.

BOARD PRESIDENT’S REPORT (continued)

President Williams reminded members that Dr. Koons’ evaluation is due by May 31 and encouraged anyone needing assistance with the online process to reach out to him directly. He noted that once all evaluations are submitted, a follow-up Zoom meeting will likely be scheduled in June to review the results, with details to be shared as the timing becomes clearer.

Board President George Williams thanked Jennifer Senavaitis for volunteering to serve on the Nomination Committee and reminded members to submit nominations for President, Vice President, or Treasurer to her by June 6. He noted that nominees will be contacted in advance to confirm their interest prior to the election.

Additionally, he mentioned that an upcoming email from Ms. Heather Morningstar, a Salisbury High School principal pursuing her doctorate, will be sent in the upcoming weeks requesting Board members to complete a brief survey for her research. President Williams asked everyone to please complete that survey.

President Williams ended his report by wishing those running in the election tomorrow good luck.

CORRESPONDENCE TO THE BOARD/CLIU UPDATE

Dr. Koons began his report by noting that Gemma, the newest CLIU Facility Dog, would not be in attendance tonight, but provided a flier with Gemma’s picture.

Dr. Koons then gave the Board several updates and began by congratulating Dr. Mark Scott and Ms. Jeanne Coy on a successful IDEA 611 Audit. For context, IDEA 611 funds are federal special education pass-through funds that support the excess costs of educating children with disabilities, helping schools meet the requirements of the Individuals with Disabilities Education Act (IDEA).

Dr. Koons also shared a lighthearted moment from a recent event at the MDS program at Sheckler Elementary in the Catasauqua School District, where he had the unique opportunity to perform as Fozzie the Bear. In his role, he interviewed Kermit the Frog following his return from a space journey. Highlights included students enthusiastically echoing “Wocka, wocka, wocka!” after each joke, joyful interactions with staff and students, and an impromptu “Space Dance” featuring Fozzie’s moonwalk.

Finally, Dr. Koons reported on the Legislative Breakfast held on May 8, which brought together area Superintendents and six local legislators. The group engaged in meaningful discussions around five key legislative priorities: Equitable School Funding Reform, Cyber Charter School Funding, Special Education Funding, Student Behavioral Health and School Safety, and Educator Recruitment and Retention. Advocacy remains a strong focus in support of the IU and its 14 member districts.


President Williams left the Board meeting at 6:45 p.m.
